THIS VOLUNTARY RELEASE OF RIGHTS AND WAIVER OF LIABILITY (the "Release") is executed on the date written below by the Participant identified above, and, if applicable, his/her parents/guardians identified above ("I" and/or "We"), in favour of CTV Television Inc. and co-sponsors, promotional partners and prize suppliers and their respective affiliated and associated companies (the "Released Companies"). In consideration of the mutual covenants and conditions contained in this Release, and in additional consideration of being permitted to participate in any activities on CTV News Star ("Activities"), the undersigned hereby agree as follows:

1. Waiver of Claims.
